#### **MONEY WEEK**

Under the new OFSTED framework, schools should, as part of the curriculum, enable pupils to develop workplace and other skills that will contribute to their future economic well being. No matter what path our children take in life, money will always play a part. We, at Fairlands, believe that it is important to introduce the concept of money at an early stage in a child's education.

This is why we recently launched our annual Money Week across the whole school, which proved to be a huge success. The Money Week activities were mainly taught through maths lessons, with class shop role-play areas and children buying items and giving the correct change. Lots of practical money maths activities were held with children playing money games, discussing the importance of money and understanding why we need it for both spending and saving. We paired older and younger children and they discussed pocket money and savings.

We held a fair after school, towards the end of the week that was attended by a huge number of children and parents. Each year group made something in their class relating to their curriculum topic to sell on the day. Foundation stage made the most profit - £75. The children were told about the importance of thinking about others less fortunate than ourselves, and were all happy that we were donating some of the money raised to the Oxfam charity to buy a goat for somebody in another country. The children in each Year group will have a say in how the rest of the money raised is spent, as they will be able to buy something for their class or outside area.

#### **SAFEGUARDING**

The Government has defined the term 'safeguarding children' as:

"The process of protecting children from abuse or neglect, preventing impairment of their health and development, and ensuring they are growing up in circumstances consistent with the provision of safe and effective care that enables children to have optimum life chances and enter adulthood successful" Ofsted have adopted the definition used in the Children Act 2004 and the DfES guidance document: 'Working Together to Safeguard Children' (2006). This can be summarised as follows:

- protecting children from maltreatment
- preventing impairment of children's health or development
- ensuring that children are growing up in circumstances consistent with the provision of safe and effective care, and
- undertaking that role so as to enable those children to have optimum life chances and to enter adulthood successfully.

#### How will it affect the school?

Safeguarding is a concern that needs to be adhered to all school personnel, parents and children. For it to work effectively we all need to buy into it. With this in mind the school have been taking measures to ensure we meet all the requirements under safeguarding. At Fairlands Primary School & Nursery, we are concerned about the welfare and safety of our pupils and our aim is to create an environment in which the children feel secure, valued, listened to and taken seriously.

The school follows the procedures established by the Hertfordshire Area Child Protection Committee. All school staff are particularly well placed to observe outward signs of abuse, changes in behaviour and failure to develop because they have daily contact with children. They are all aware of the important role the school has in the early recognition of the signs and symptoms of abuse or neglect and the appropriate referral process.' Working Together to Safeguard Children' (1999 DoH) requires all schools to follow the procedures for protecting children from abuse. With this in mind the school has all the appropriate procedures in place for responding to situations in which they believe that a child has been abused or are at risk of abuse. These procedures also cover circumstances in which a member of staff is accused of, or suspected of, abuse. A Designated Senior Person has been nominated and trained and has the responsibility for coordinating all the actions within the school and liaising with other agencies. We also have specific governors nominated and trained to oversee and support Safeguarding policies and issues.

Safeguarding Children in Education also states, "Parents should be made aware of the school's Child Protection Policy and the fact that this may require cases to be referred to the investigative agencies in the interests of the child".

#### What measures are in place in the School?

- Child Protection and Health and Safety policies are in place and adhered to by all members of teaching and support staff.
- All teaching and support staff have had a Criminal Records Bureau (CRB) check carried out on them and documented.
- We ensure that accurate records relating to individual children are kept separate from the academic file in a secure place and marked 'Strictly Confidential'.
- All the outside fencing area has been improved (the new black fencing) to ensure the safety of the children in all outdoor spaces.
- We aim to provide guidance to parents, children and staff about obtaining suitable support, this includes Parentline Plus.
- We promote children's good health and well-being.

#### **PARENT FORUM**

You may be aware that Mr Staples holds a Parent Forum every half term to which all parents/carers are invited to discuss any suggestions/queries/issues with the school.
